

**Below you will find Q&As on how to access and use your EOPS Spring 2026 book voucher ONLINE.**

**How do I find out if I am eligible for the book voucher?**

**Beginning Monday, February 9, 2026** you may access your book voucher information ONLINE through your student portal (MyGCC). Go to Other Services and click on the EOPS Book Voucher tab.

Your **personalized book voucher page** will display the Spring 2026 book voucher information under **Spring**.

**What if I am not eligible for a Winter book voucher?**

If you are not eligible for Spring 2026 book voucher, you will see **\$0.00** listed for the award amount. Click on \$0.00 to find out the reason for your ineligibility.

**How can I use my book voucher?**

You can use your book voucher to purchase your textbooks from GCC bookstore ONLINE and get your books shipped to your home for \$7.50, or you can schedule a pickup time to get your books directly from GCC bookstore. 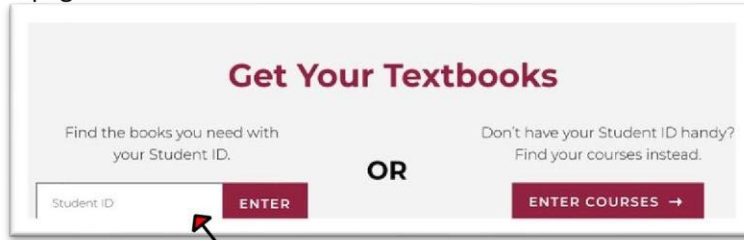

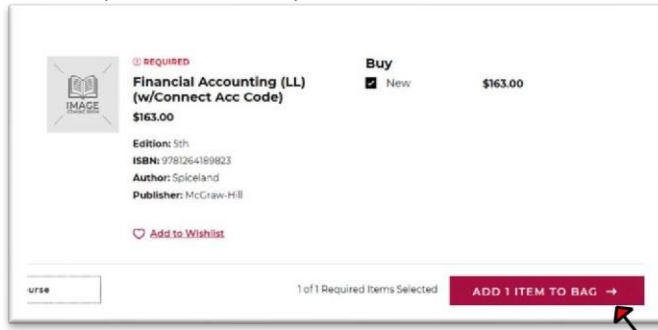
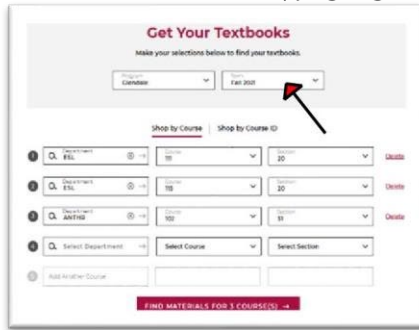
**STEP-BY-STEP GUIDE FOR PURCHASING TEXTBOOKS WITH EOPS BOOK VOUCHER**

1. Click [here](#) to go to the GCC's [bookstore home page](#). Click on **Textbooks** icon.

2. Enter your **Student ID** on the next page.

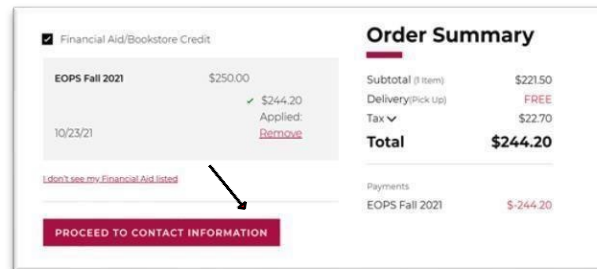
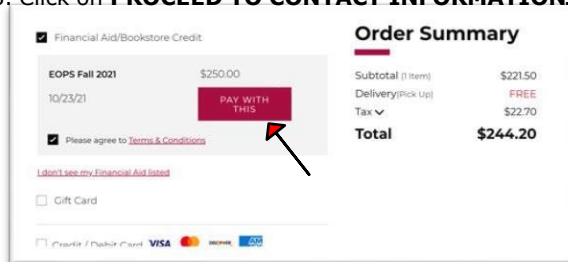


3. Select **Program** and **Term** to get a list of textbooks for courses you are enrolled in.  
4. Add each book to the shopping bag. Check out and proceed to delivery method.



7. You will see the EOPS book voucher amount for this semester. Click on **PAY WITH THIS**. If the total amount is less than the book voucher, no additional payment is necessary. Otherwise, you will be asked to provide an additional form of payment. Select **agree to Terms & Conditions**.


8. Click on **PROCEED TO CONTACT INFORMATION**.


